

## Call for proposals for action grants to support transnational projects on training of justice professionals covering civil law, criminal law or fundamental rights

Deadline: 22 March 2022

Budget line: EUR 5 000 000

Title: Nurturing a common EUropean judicial cultuRe ThroUgh cRoss-profEssional trainings

**Acronym:** NURTURE

Judicial trainings of professionals have proven to be an effective approach in terms of guaranteeing the proper and valid enforcement of EU law. The latter is due to the fact that they advance and encourage the trust between the justice professionals in the different Member States in terms of judicial cooperation and also enhance the implementation of EU's principles. Despite the successful implementation of the European Judicial Training Strategy (2011-2020), which is attributed to the great number of participants in the trainings, currently is registered a decrease in comparison with 2018. Besides, the number of participants from the different Member States and the different legal professions is still unequal that might affect the consistent and systematic enforcement of European legislation. Indeed, data shows that the significant decrease in the overall number of participants is due to the decline in lawyers' trainings. Accordingly, the European Commission elaborated the European Judicial Training Strategy that will cover the period between 2021-2024. The aim of the strategy is to assist the judicial systems and professionals in regard to arising challenges like the COVID-19 pandemic which underlined the importance of digitalizing the judicial sphere and the necessity of more effective judicial cooperation empowered by new technologies.

Therefore, the NURTURE project will address the new European Judicial Training Strategy for 2021-2024 and, in particular, will focus on cross-professional trainings so as to enhance the dialogue between the different judicial professions. More specifically, the training which will be conducted under NURTURE's implementation will be based on Directive (EU) 2016/680
